1. Zoning in the Neighborhood Revitalization Area

Staff gave a brief review of what was covered during the discussion at the last meeting regarding Accessory Dwelling Units (ADU) and the recommendation that the lot size requirement be reduced from 10,000 sf. to 7,500 sf. to allow for the

Staff advised On December 12, 2024, an update was received on the Environmental and Climate Justice Community Change Grants Program (CCGP) stating the program received approximately 2,700 applications requesting over \$40 billion in funding, with limited funds remaining due to prior awards. Many applications were submitted late in the process, requiring months for evaluation. The Office of Environmental Justice and External Civil Rights (OEJEER) is continuing the review process and expects it to extend into spring 2025.
